7.1 - CONTRACT APPROVAL FOR LIVE FIRE TRAINING STRUCTURE

The Swede Survival Phase V Standard Fire Training System

A statement describing the unique or specialized features of the product or service.

The reason for this specific purchase is due to the uniqueness of the product, safety value of the product, availability of the product and timeline needed for project completion. The Swede Survival Phase V Standard Fire Training System has been designed with the training needs and safety of our firefighters at the forefront. Draeger Inc. has been able to completely customize a new live fire training facility for the HFTA fire training facility and its JPA members.

A statement of why the department requires that the product or service has such unique or specialized features (e.g. a statement of why a product or service without such features would not meet the department's needs).

Draeger, Inc. is the sole source of supplier for the Swede Survival Phase V Standard Fire Training System within the United States and U.S. territories. Draeger's professionally licensed project management team shall oversee the design, build, transportation and installation of this system as well as a two-day operations and maintenance training for designated teaching cadre within the HFTA.

We are requesting approval for the purchase of the Phase V Swede Survival System burn building. The proprietary make-up of this product does not allow for competitive bidding. No other manufacturer can deliver this specific product that our training facility needs. This specific product allows for customizable design with the safest possible training, extended warranty as well as expedited build time.

A description of HFTA's efforts to locate all possible suppliers of such product or service.

The HFTA staff and live fire cadre have compared the various different styles of live fire training buildings over the past eighteen months. Our live fire training cadre visited numerous facilities throughout the state of California and around the Country to see which live fire training building provides the safest training environment as well as most beneficial training opportunities. After reviewing the training needs of the HFTA, it has been determined that the Swede Survival Phase V Standard Fire Training System is the only system that meets all of the needs of the HFTA and its personnel.

A statement that, in spite of its efforts, the department has been able to locate only one supplier of the product or service in question.

Other training facilities that were examined, were eliminated due to one of all of the following issues:

- Limited warranty
- Limited or no customization option
- Training not included
- Construction and oversight not included in cost
- Lack of detail and safety measures
- Lack of reliability once built
- Not honoring warranties
